Progress Report on the Implementation of IWC Recommendations on Strengthening IWC Financing

Submitted by the Chair of the Intersessional Correspondence Group on Strengthening IWC Financing

The Commission is requested:

- note the progress made by the Intersessional Correspondence Group on Strengthening IWC Financing (ICG-SF)
- endorse the next steps outlined in sections 1.1 to 1.4.
- adopt the Code for Ethical Fundraising, and review by IWC68 (IWC/67/FA/14)
- adopt the revised terms of reference for the ICG-SF (Annex 4)
- adopt the future workplan of the ICG-SF (Annex 5)

Background

The Intersessional Correspondence Group on Strengthening IWC Financing (ICG-SF) was established at IWC62 in 2010 and reports to the Finance and Administration Committee. The Group aims to find ways to support the rebuilding and maintenance of healthy whale populations. In 2014, it made a series of recommendations to help create the right environment to encourage external funders to contribute to the work of the Commission and, in the long term, to identify what needs to be done to improve the reliability of financing to support increasing and sustained programmes of work. These recommendations were endorsed at IWC65 in 2014. In the intersessional period towards IWC66 many of these recommendations were implemented and, at IWC66 in 2016 a progress report and an updated work plan were presented to the Commission. In October 2016, the Commission endorsed the ICG-SF's progress report and its work plan for the intersessional period (IWC/66/F&A08).

The current group members comprise Australia, Belgium, Costa Rica, Ecuador, France, Germany, Mexico, Monaco, United Kingdom, United States of America. The Chair is Stephanie Langerock (Belgium). Environmental Investigation Agency and Natural Resources Defense Council have joined the group as observers. The group remains open for new members.

Governance arrangements

As noted above, the Intersessional Correspondence Group on Strengthening IWC Financing (ICG-SF) reports to the Finance and Administration Committee. The Steering Group for the Voluntary Conservation Fund (SG-VCF) was established in January 2017 (see section 1) and it also reports directly to the Finance and Administration Committee. Both groups operate independently, with separate officers, membership and terms of reference.

1. Current work plan

The IWC has made significant progress in the implementation of the recommendations of the ICG-SF. The ICG-SF has completed virtually all actions taken up in the workplan approved by IWC66. Annex 1 gives an overview of the state-of-play of the current workplan, including the activities that might continue in the future workplan of the group.

The main activities undertaken to implement the workplan are summarised here below and the proposed next steps are outlined.

1.1. Establishment of the Steering Group for the Voluntary Conservation Fund

During IWC65, the IWC adopted the Terms of Reference for the Voluntary Conservation Fund Steering Group. The Voluntary Conservation Fund can receive funds that are earmarked for specific projects or that are put into a general fund to support projects in priority categories¹. The Steering Group for the Voluntary Conservation Fund (SG-VCF) was established in January 2017. The group is currently chaired by Catherine Bell (UK) and is still open for membership. An overview of its current membership and a report of its activities can be found in document IWC/67/FA/04.

1.2. Budgeted Work Plans

The ICG-SF was tasked to develop budgeted work plans including a list of projects that require external funding and, in addition, to develop project templates and outline standard costs, to support the development of project proposals.

When reporting to the Conservation Committee at IWC67 in 2018, the Chairs of the Standing Working Groups have been invited to identify the resource requirements for their recommendations including whether implementing the recommendation would incur:

- No additional cost e.g. can be undertaken on a voluntary basis by Governments
- Core Secretariat time is available i.e. no additional funds needed
- Additional external funds e.g. Voluntary Conservation Fund, funds from IWC Contracting Governments or funds from external sources (costings provided in project template see Annex 2)

Where additional external funds are needed, Working Groups are requested to provide additional details on the tasks or projects which will assist the Steering Group for the Voluntary Conservation Fund in allocating funding and/or the Secretariat in efforts to fund raise from donors.

To assist the chairs of the Conservation Committee Working Groups the ICG-SF has prepared a project template for recommendations that would require additional funding. Following IWC66, a template (Annex 2) was developed by the ICG-SF and circulated by email by the Chair of the ICF-SF in 2017 and again in the first half of 2018.

In addition, the Secretariat is ready to support this process through the development of guidance on standard costs e.g. calculating the cost of core secretariat time, external salary costs, subsistence rates etc.

Next steps:

- All Standing Working Groups are invited to insert an action on the use of costed work plans and projects in their reports and future workplans.
- Once a list of costed work plans and/or projects has been compiled and endorsed at IWC67, Working
 Groups supported by the Secretariat, can start to prepare funding proposals and submit grant applications
 to support activities recommended by the Commission and/or make applications to the Voluntary
 Conservation Fund.
- The ICG-SF will provide advice on any recommendations of the governance review that relate to external fund raising and associated projects, including the enabling conditions for fund raising e.g. budgets and costed work plans.

1.3. Funding opportunities

The ICG-SF agreed that the Secretariat would undertake an ongoing review of available funding streams that could potentially be accessed to support the implementation of the Commission's recommendations. In addition, the ICG-SF was tasked with reviewing opportunities to engage with Trust Funds/Foundations and their relevance to the IWC work programme, including outreach where appropriate.

The Secretariat has compiled an initial list of external funding opportunities (Annex 3) and they will continue to work with the Conservation Committee and its Standing Working Groups to identify additional funders, improve geographic coverage, etc. Contracting Governments, IGOs and NGOs are invited to send any additional funding sources they might know of to the Secretariat for inclusion in this list. Once proposed costed work plans and/or projects have been endorsed by Commission, this list of funders can be used by Standing Working Groups, in collaboration with the Secretariat, to seek funding to implement these.

A wide variety of Trust Funds have been identified, many of which may be relevant to the work of the IWC. This suggests that there may be opportunities to seek funds from these organisations and it is proposed that Trust Funds/Foundations be included in the list of potential funders that are considered for funding applications and outreach as appropriate.

In addition, it may be useful to explore whether financial support from industry may provide opportunity to fund some of the work of the IWC. Any action taken in this regard will be underpinned by the Code for Ethical Fund Raising (Section 1.4) to ensure appropriate safeguards were in place.

Next steps:

- The Secretariat will collate information on funders received so it can be used by the Standing Working Groups and Conservation Committee needing funds in the future.
- Trust funds and industry sources to be included as potential funders and, if appropriate, approached for funding during the intersessional period, in collaboration with the relevant Working Groups and taking into account the Code for Ethical Fund Raising.

1.4. Code for Ethical Fundraising

A draft Code for Ethical Fundraising (see document IWC/67/FA/14) has been developed in order to guarantee appropriate safeguards as well as full transparency of all fundraising activities. Once endorsed by the Commission, the ICG-SF proposes to use this code in the intersessional period and to review it at IWC68.

Next steps:

- Apply the Code for Ethical Fund Raising, review in the intersessional period and and bring any proposed revisions to IWC68.

2. Voluntary Conservation Fund

The Voluntary Conservation Fund was established in 2014. The ICG-SF's workplan includes a number of actions that are related to the management and the disbursal of the Voluntary Conservation Fund by the VCF Steering Group and are reported in document IWC/67/FA/04.

During the last intersessional period the fund has benefited from several donations. As at 31 August 2018, the balance of the Voluntary Conservation Fund is £159,612 (Table 1). Over the intersessional period, work has progressed on bycatch, the Whale Watching Handbook and the database of recommendations using donations from the Voluntary Conservation Fund.

Since the IWC 66 meeting, the Government of France contributed £31,812 in November 2016 to support bycatch mitigation. In 2017, an additional, £100,000 was contributed by the UK which remains to be allocated to a particular work stream. In July 2018, the fund received £21,439 from the Government of New Zealand (NZD 40,000), towards development of a pilot online Conservation Database, promotion and dissemination of the Whale Watching Handbook and support for bycatch mitigation/disentanglement with final allocations to be determined. In August 2018, the US made a contribution to the VCF with £9,200 (USD12,000) allocated to bycatch, £2,250 (USD3,000) to whale watching and £7,500 to Ship Strikes (USD10,000).

The distribution of the remaining funds will be allocated by the Voluntary Conservation Fund Steering Group according to its criteria and allocation process.

Next steps:

- The Steering Group for the Voluntary Conservation Fund will continue to oversee and report on the allocation and dispersal of the funds of the VCF. The Secretariat will continue the administration of the Fund and, working with the Steering Group for the Fund, explore ways to publicise the Fund and encourage contributions.

3. Updated Terms of Reference and Future Workplan of the ICG-SF

Although the ICG-SF has completed most the actions of its current workplan, some actions would benefit from further development and support from the ICG-SF while they are being put in place. This includes assisting the Secretariat in fulfilling the mandate it has received with regards to their engagement with other organisations and identifying new opportunities, to take forward possibilities for joint fund raising or partnership work in order to implement the Commission's recommendations and to reach out to potential funders as well as for the development of grant proposals etc.

Hence there are a few things that the ICG-SF might do in the forthcoming intersessional period that relate to the current mandate or to new activities of relevance. Revised Terms of Reference are proposed in Annex 4. In addition, a new workplan (Annex 5) is proposed for adoption.

Next steps:

- Upon endorsement the ICG-SF will start implementing the future workplan in the next intersessional period.

Annex 4: Proposed Revisions to the Terms of Reference for the Intersessional Correspondence Group on Strengthening IWC Financing

- 1. Oversee and review the implementation of medium term actions needed to strengthen IWC financing including continued development of costed work plans.
- 2. Advise and assist the Secretariat in identifying appropriate organisations for the purposes of helping to strengthen IWC financing, and in approaching and building relationships with these organisations.
- 3. Continue work to develop and review a Code of Ethical Fundraising.
- 4. Advise and assist the Secretariat and Working Groups in making applications for external funds to support relevant IWC projects.
- 5. Provide advice on any recommendations of the IWC Governance Review that relate to external fund raising and the enabling conditions for fund raising activities e.g. budgeting and costed work plans.
- 6. Continue to examine ways to integrate conservation funding into the overall budget considering both core and voluntary funding and make recommendations as appropriate.
- 7. Report to the Finance and Administration Committee annually on progress, making any recommendations for further work as needed towards long term IWC financing.
